

CONSENT AND RELEASE

I represent and warrant that I have obtained or will obtain, at my own expense, written consents and releases in a form acceptable to AKC from all persons and for all property (including dogs) appearing in the Images which shall permit AKC to exercise all rights granted under this agreement. Such consents and releases will not create any obligation on AKC's part to third parties, and those parties shall have no claim whatsoever against AKC under any circumstances. I shall provide such releases upon AKC's request.

I agree to be solely responsible for any legal liability arising out of or relating to the Images. I agree to release, indemnify, defend and hold harmless AKC, its licensees, agents, assignees and others working for it or on its behalf from any and all liability that may occur in connection with the use of the Images by AKC, its licensees, agents, assignees and others working for it or on its behalf and arising out of or relating to the breach or alleged breach of the foregoing representations and warranties.
