AKC Statement Urges New Import Protocols to Protect Pet and Public Health


Every day, thousands of pets are imported into the continental United States for the purpose of sale or transfer in retail or retail rescue markets. According to the American Pet Product Distributors Association (APPA) annual survey, Americans currently own approximately 80 million dogs, and acquire approximately 8 million dogs per year. Even if the per capita rate of demand for pets holds static, population increases alone continue to create a growing demand for pet dogs – more than are currently available in the United States.

AKC Adopts New Legislative Position Statement on Dog Training

Recently, the American Kennel Club has observed a disturbing trend in legislative proposals at the state and local level aimed at arbitrarily restricting standard, accepted dog training methodologies and approaches. Some of these proposals, such as those observed in New York State and Hillsborough County, Florida, created extensive new licensing requirements for all trainers, established arbitrary and extensive training and paperwork requirements for any dog ever attending even a single training class, including a "drop-in" training class; and broadened the definition of professional trainers subject to licensing to include kennel clubs, dog training clubs and other not-forprofit community centers that provide basic dog training as a community service. Some measures would also designate or allow animal protection groups to arbitrarily determine which training methodologies would be allowed.

AKC Adopts New Position Statement on Tethering

The American Kennel Club has seen a troubling increase in proposed anti-tethering laws in states and local municipalities seeking to prevent animal cruelty. AKC shares concerns about abuse and does not tolerate animal cruelty. However, proposals that arbitrarily ban tethering could actually cause harm to some dogs and are unlikely to stop bad actors already in violation of animal welfare laws.

Legislative Information and Updates

Currently, 28 states, the District of Columbia, and Puerto Rico are currently in session, and seven states are in a special legislative session. AKC Government Relations is currently tracking more than 1,860 bills on the federal, state, and local levels. A large number of these bill have been carried over from 2017. Additional bills will be introduced as more legislatures come back into session for the new year.
