Exhibitors should follow their veterinarian's recommendations to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

A copy of a dog's vaccination record, including a current rabies certificate, must be present for all dogs at the event.

OBEDIENCE CLASSIC DESCRIPTION

The AKC Obedience Classic is a two-day competition. In the Novice, Open and Utility Classes the handler/dog team will compete a total of three times. In the Masters Class the handler/dog team will compete a total of six times, three in Open and three in Utility.

OBEDIENCE CLASSIC DOG ELIGIBILITY

All dogs meeting the following requirements are eligible to enter the event, which will be held in conjunction with the 2015 AKC/Eukanuba National Championship and the 2015 AKC Agility Invitational. In addition, FCI membership countries will also be invited to send teams of up to three dogs to this event. **Qualifying Period July 1, 2014 – June 30, 2015**

All references to titles indicate AKC titles.

- **Novice Class Eligibility**
 - Must have earned a CD title (at any time)
 - The qualifying scores earned to achieve the CD title may be part of the scores required if they were earned during the qualifying period.
 - May not have earned the CDX title during the qualifying period.
 - A dog must earn six (6) qualifying scores in the Novice class (A and/or B), or one (1) High Scoring Dog award in Novice during the qualifying period.
- **Open Class Eligibility**
 - Must have earned a CDX title (at any time)
 - The qualifying scores earned to achieve the CDX title may be part of the scores required if they were earned during the qualifying period.
 - May not have earned the UD title during the qualifying period.
 - A dog must earn six (6) qualifying scores in the Open class (A and/or B), or one (1) High Scoring Dog award in Open during the qualifying period.
 - OTCH title dogs may not enter this class.

OBEDIENCE CLASSIC DOG ELIGIBILITY CONT'D

- **Utility Class Eligibility**
 - Must have earned a minimum of the UD title (at any time)
 - The qualifying scores earned to achieve the UD title may be part of the scores required if they were earned during the qualifying period.
 - A dog must earn six (6) qualifying scores in the Utility (A and/or B) or one (1) High Scoring Dog award in Utility during the qualifying period.
 - OTCH title dogs may not enter this class.

- **Masters Class Eligibility – Open and Utility**
 - Must have earned a minimum of the UD title (at any time)
 - The qualifying scores earned to achieve the CDX and/or UD title may be part of the scores required if they were earned during the qualifying period.
 - A dog must earn six (6) qualifying scores of 193 or better in Open B during the qualifying period; and
 - A dog must earn six (6) qualifying scores of 193 or better in Utility B during the qualifying period.
 - OTCH titled dogs may enter this class.

A dog may only be entered in **one** class, Novice, Open, Utility or Masters and must be entered in the highest level class for which they have qualified.

PREFERRED TEAM CLASS DESCRIPTION

We are excited to offer a non-regular Preferred TEAM CLASS competition on Sunday at the Obedience Classic. Be creative and have some fun with your friends by entering the TEAM CLASS. Participants are encouraged to create a theme for their team, with a special award for the “**Best Team Theme.**”

Let your imagination soar with your team theme! Handlers and dogs should dress the part of this fun-filled competition. Will it be a beach bash, favorite movie, Mardi Gras? The ideas are limitless! Remember to include the name of the team on the each team dog's entry form and select a Team Captain.

PREFERRED TEAM CLASS ELIGIBILITY / ENTRY LIMITS

Preferred Team Class Eligibility, Entry Limits & Entry Fee

The non-regular Preferred Team class will be for teams of any four dogs that are eligible to enter obedience events. The entry fee is \$55.00/per team. Five dogs may be entered, one to be considered an alternate, for which no entry fee will be required. However, only the same four dogs will perform all exercises. Dogs may be handled by the owner or any other person, need not be entered in another class at the Obedience Classic, and need not have obedience titles. A separate official **Team Entry Form** must be completed in full for each dog entered. Team entries must include a Team Name & Team Captain. No dog may be entered on more than one team.

Teams entries will be accepted beginning **Monday, July 20, 2015** and must be received by the closing date of **October 16, 2015 at 4:00 p.m.** Entries will be limited to 12 teams. When entry limits have been met, a wait-list will be kept.

PREFERRED TEAM CLASS REGULATIONS

There will be two judges, one of whom will call orders while the other scores the team's performance. The teams will be judged one at a time. The dogs on a team will perform the exercises simultaneously and will be judged as specified for the Preferred Novice class, except that a Drop on Recall will be used in place of the Recall exercise. In all exercises except the Drop on Recall, the teams have the option of executing the judge's orders on the team captain's repeat of the command.

In the Figure Eight portion of the Heel on Leash exercise, five stewards will be used. The stewards will stand 8 feet apart in a straight line. Each handler, with the dog sitting in heel position, will stand about equidistant from each of two stewards with all members of the team facing the same direction. On orders from the judge, the team will perform the Figure Eight, each handler starting around the steward on his/her left and circling only the two stewards between whom he/she had been standing.

In the Drop on Recall exercise, the handlers will leave their dogs simultaneously on order of the judge. The dogs will be called or signaled in, one at a time, on a separate order from the judge to each handler. Handlers will, without any additional order from the judge, command or signal their dogs to drop at a spot midway between the line of dogs and the handlers.

Each dog will remain in the down position until all four have been called and dropped. The judge will give the order to call the dogs, which will be called or signaled simultaneously. The finish will be done in unison on order from the judge.

PREFERRED TEAM CLASS SCORING

Individual dogs' scores will be based on the performance of the dogs and handlers individually plus team precision and coordination. Each dog and handler will be scored against the customary maximum for a team total of 800 available points. Individual dogs' scores will not be recorded.

1. Heel on Leash & Figure 8	160 points
2. Stand for Examination	120 points
3. Heel Free	160 points
4. Drop on Recall	160 points
5. Stay – Sit or Down	200 points

No dog may be entered in more than one class and **must** be entered at the highest level they are eligible for, except for Team. Any dog eligible to enter an obedience event is eligible to be entered in Team and maybe entered in another class at this event.

Entries will be accepted on a first-come, first-serve basis and will not be accepted until the date and time listed above.

Entries not on the Official AKC Obedience Classic or the Preferred Team Class Entry Forms or photocopies of the entry forms without the Agreement and Rules on the reverse side are NOT ACCEPTABLE. No entry shall be made or accepted, which specifies any conditions as to its acceptance.

In order to submit your entry: It must be delivered by USPS, or a multi-state or multi-national postal or carrier service including but not limited to USPS, FedEx, UPS, DHL, etc. **No entries will be accepted by hand delivery or phone.**

Dog's Call Name: Please be sure to include your dog's call name on the entry forms. This will be used for award announcements.

Errors on Entry Forms: Owners are responsible for errors on entry forms and no entry fee will be refunded in the event of such errors or cancellation of entries after the trial has closed.

Illegible entries: Will not be processed and will be returned to the exhibitor. Returned checks do not constitute a valid entry. A twenty-five (\$25.00) dollar collection fee will be added to the amount of each returned check.

Limited Entries: Entries will be limited to 72 in Novice, 64 in Open, 56 in Utility and 56 in Masters. Notifications will be sent via email to advise you of your entry status. As a class fills a wait-list will be kept, i.e. entries received after the limit has been reached will be listed in the order received. If an exhibitor cancels an entry no later than the closing date listed the first entry on the wait-list will be contacted no later than **Monday, October 19, 2015.**

Confirmation of entry: You will receive a confirmation email that your entry has been received and accepted. If you do not receive an email confirmation within 2 weeks of sending in an entry please contact us at OBClassic@akc.org.

Cancellation of Entry: Requests to cancel an entry will be allowed up until the closing date and time, **Friday, October 16, 2015 @ 4:00 p.m.** You may cancel your entry via email sent to OBClassic@akc.org or by fax at (919) 816-4204. Refunds for cancellations will be made within 45 days after the closing date for the event.

Changes to entry forms: Changes, additions or corrections to entry forms must be received in writing prior to the close of entries. Updates are to be sent to OBClassic@akc.org.

Bitches in Season: Are not permitted to compete in Obedience Events. Refunds will be processed if the Trial Secretary is notified no later than one half hour prior to the start of judging. Veterinarian statements must be provided to the Trial Secretary in writing. They may be hand delivered at the event, emailed to OBClassic@akc.org or faxed to (919) 816-4204.

Entry Fees: Entry fees are required with each entry. **NO ENTRY FEE** will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused by a judge or veterinarian, or barred from competition by the action of the Event Committee.

There will be no refund for duplicate entries.

All exhibitors should obtain a copy of the *Obedience Regulations* by downloading them from the American Kennel Club website at <http://www.akc.org/rules/>. **This event will be judged according to the *Obedience Regulations* effective December 1, 2015.**

ADDITIONAL SITE INFORMATION

A full service food concession is available on site.

The American Kennel Club and the Orange County Convention Center will not be responsible for any lost or damaged items left at the show site.

Exhibitors are responsible for cleaning up after their dog(s) at the show site and hotels. Any exhibitor failing to do so may be asked to leave the show grounds without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

Parking Fees Orange County Convention Center (OCCC) controls the parking lots. There will be a \$10.00 daily parking fee for cars. Oversized vehicles will be charged a higher rate. This fee includes in and out privileges into the OCCC parking lot with a dated receipt for that day only. If you are unable to find your receipt you will be required to pay the parking fee again, so be sure to hold on to your receipts. NO overnight parking, except RVs reserved in the designated location.

Admission Tickets each exhibitor entered will receive a ticket for each day they are entered. The ticket will be included in your exhibitor check-in envelope. Additional tickets for family and friends must be purchased. Ticket purchasing information will be available on the AKC web site prior to the event.

Entering/Exiting the Facility a hand stamp must be obtained to regain entry into the area and not all exits will have personnel available to stamp upon leaving the facility. Upon arrival have your hand stamped for the day to avoid a delay in re-entry. Review your final confirmation letter for specific locations where stamps will be available.

IMPORTANT NOTICE TO ALL EXHIBITORS
PLEASE READ THE ENTIRE SECTION CAREFULLY

EXHIBITOR CHECK-IN: Exhibitors will be allowed to check-in and set-up beginning on Friday, December 11th. If you cannot check-in until Saturday morning you must do so 30 minutes prior to the start of judging. You will receive your armband, event catalog and an event souvenir bag at check-in. Once the time and location for check-in is determined all exhibitors will be notified by email.

In the event you are not able to check-in and receive your admission tickets prior to Saturday morning, please notify Lisa Strickland at OBClassic@akc.org or 919-816-3816.

Exhibitors MUST check-in at EACH ring, EACH day.

CRATING: Each dog entered in the event will be allotted one 3'x5' space. Un-entered dogs will only be allowed in the facility if they can share the crate with an entered dog, or if their crate can be stacked on top of an entered dog's crate within the 3'x5' space allotted.

Soft sided crates are only permitted in the obedience and agility areas.

A "crate" is defined as having a top, bottom and 4 walls, all interconnecting, thus preventing the dog from escaping.

Each exhibitor will be required to display an information card on the outside of each crate; card(s) will be supplied at check-in. The information card must have your name and on site emergency contact information.

NO EX-PENS will be allowed in the facility. No dogs are permitted to be crated or groomed on any carpeted area.

ALL DOGS MUST BE ON LEASH: Dogs must be on leash, held by the handler at all times while on the trial grounds except when in the designated warm-up area or competing in the ring. Dogs may NOT be on retractable leads or long-lines while inside the building. Failure to maintain control of a dog may result in an Event Committee hearing.

SPECIAL TRAINING COLLARS ARE PROHIBITED.

WARM-UP RING: A warm-up ring will be provided for dogs entered in the AKC Obedience Classic and the AKC Junior Classic in accordance with the *Obedience Regulations*, Chapter 1, Section 33. This ring will be monitored and if there are any problems, the ring will be closed. Exhibitors will be respectful of each other.

CATALOGS: All exhibitors will receive a complimentary copy of the commemorative catalog in their check-in packet. Additional copies may be purchased at the event.
